## Charge Lines Changes

- The Georgiana-Oak Grove Charge in the West Central District is dissolved, and both churches become station churches.
- With the closing of Loachapoka UMC, the Armstrong/Loachapoka Charge in the Southeast District is dissolved, and Armstrong becomes a station church.
- With the closing of Morris Chapel, The Lee Circuit in the Southeast District continues and consists of Hopewell and Pierce Chapel.
- With the closing of Flomaton UMC, the Flomaton/Baggett's Chapel Charge in the Southwest District is dissolved and Baggett's Chapel becomes a station church.
- With the closing of Irvington UMC, the Theodore/ Irvington Charge in the Southwest District is dissolved and Theodore becomes a station church.
